Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	\$5,500 individual <a href="#">plan</a> / \$11,000 family aggregate.  <a href="#">Co-insurance</a> and <a href="#">co-payments</a> do not apply to the <a href="#">deductible</a> . This benefit combines your prescription drug and medical <a href="#">deductibles</a> .	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount each <a href="#">plan</a> year before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay. Your <a href="#">plan</a> year: 01/01/2021 through 12/31/2021.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes, <a href="#">preventive care</a> , wellness drugs	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">co-payment</a> or <a href="#">co-insurance</a> may apply. Are there other <a href="#">deductibles</a> for specific services?	No. There are no other specific <a href="#">deductibles</a> .	You don't have to meet <a href="#">deductibles</a> for specific services.
What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	\$6,900 individual <a href="#">plan</a> . Family plans have an individual <a href="#">out-of-pocket limit</a> of \$8,550 and \$13,800 aggregate family. <a href="#">Prescription drugs</a> : \$1,400 individual <a href="#">plan</a> / \$2,800 family aggregate. Medical and prescription drug out-of-pocket limits are combined.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a <a href="#">plan</a> year for covered services. If you have other family members in this <a href="#">plan</a> , the overall family <a href="#">out-of-pocket limit</a> must be met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	Premiums, <a href="#">balance-billing</a> charges, adult vision care, adult dental services and health care this <a href="#">plan</a> doesn't cover. Will you pay less if you use a <a href="#">network provider</a> ?	Yes. **Your Grievance and Appeals Rights:**

 **This is not a cost estimator.** Treatments shown are just examples of how this [plan](#) might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your [providers](#) charge, and many other factors.
