What is the overall deductible ?	\$3,200 individual / \$6,400 family stacked. Co-insurance and co-payments do not apply to the deductible .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. Are there services covered before you meet your deductible ?
