What is the overall deductible?	\$7,500 individual plan / \$15,000 family aggregate. Co-insurance and co-payments do not apply to the deductible. This benefit combines your prescription drug and medical deductibles.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount each <u>plan</u> year before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay. Your <u>plan</u> year: 01/01/2024 through 12/31/2024.
Are there services covered before you meet your deductible? Does this plan provide Minimum Essential Coverage? Yes.
