Moving to Excluded - generic formulation available

- Aptiom (eslicarbazepine) tablet
- Auryxia (ferric citrate) tablets
- Brilinta (ticagrelor) tablet
- Cipro-HC (ciprofloxacin-dexamethasone otic suspension)
- Complera (emtricitabine-rilpivirine-tenofovir disoproxil fumarate) tablet
- Dificid (fidaxomicin) tablet
- Entresto (sacubitril-valsartan) tablet
- Imitrex (sumatriptan) injectable
- Iressa (gefitinib) tablet
- Kenalog-10 (triamcinolone) injection
- Korlym (mifepristone) tablet
- Lovenox (enoxaparin) injection
- Lyrica (pregabalin) oral solution
- Motegrity (prucalopride) tablet
- Nexavar (sorafenib) tablet
- Nuvaring (etonogestrel-ethinyl estradiol) vaginal ring (Excluded on NPF formulary; Nonpreferred Brand with Step Therapy on BCBSVT formulary)
- Ozobax (baclofen) tablet
- Pradaxa (dabigatran) capsule
- Premarin (conjugated estrogens) tablet
- Promacta (eltrombopag) tablet

- Purixan (mercaptopurine) oral suspension
- Ravicti (sodium phenylbutyrate) powder
- Rytary (carbidopa/levodopa ER) tablet
- Spiriva (tiotropium) Handihaler inhalation capsules
- Tassigna (nilotinib) capsule
- Tepadina (thiotepa) injection
- Thalitone (chlorthalidone) tablet
- Tikosyn (dofetilide) capsule

- Victoza (liraglutide) auto-injector (Already excluded on NPF formulary, so change only pertinent for BCBSVT formulary)

Moving to Excluded – Consider alternate product

- Baclofen solution – Alternative: baclofen tablet
- Ciprofloxacin-hydrocortisone otic suspension – Alternative: ciprofloxacin-dexamethasone otic suspension
- Genotropin (somatotropin) – Alternative: Omnitrope or Norditropin (already excluded on NPF formulary, so change only pertinent for BCBSVT formulary)
- Indomethacin suppositories
- Ondansetron 16mg ODT – Alternative: 4mg/8mg
- Sertraline capsules (150mg; 200mg) – Alternative: Sertraline tablets
- Soliris (eculizumab) injectable – Alternative: Bkemv or Epysqli
- Sulfacetamide sodium with Sulfur Cleanser - Alternative: use a covered, preferred acne product
- Triamterine capsule - Alternative: one of the following: amiloride tablet, eplerenone tablet, spironolactone tablet
- Valsartan solution - Alternative: valsartan tablet

- Zegalogue (dasiglucagon) auto-injector - Alternative: Baqsimi or Fesnius Kabi manufacturer of Glucagon Emergency Kit

Biosimilar Changes

- Basaglar moving to excluded- Alternative: Lantus or insulin glargine-ygfn
- Prolia moving to excluded - Alternative: Stoboclo (Pharmacy benefit change only)
- Rezvoglar moving to excluded - Alternative: Lantus or insulin glargine-ygfn
- Xgeva moving to excluded – Alternative: Osenvelt (Pharmacy benefit change only)

Add Quantity Limit

- Albendazole tablets
- Biltricide (praziquantel)
- Emverm (mebendazole) tablets
- Esbriet (pirfenidone) tablets
- Ivermectin tablets
- Leqembi (lecanemab-irmb) solution
- Ofev (nintedanib) tablets
- Sodium hyaluronate products (e.g. Euflexxa, Gelsyn-3)
- Stromectol (ivermectin) tablets
- Votrient (pazopanib) tablets
- Xdemvy (lotilaner) solution

Add Prior Authorization

- Arbli (losartan) Suspension
- Depen (penicillamine) tablets
- Lopressor (metoprolol) solution

Add Step Therapy

- Auryxia (ferric citrate) tablets
- Dymista (fluticasone/azelastine) nasal spray
- Nuvaring (applies to BCBSVT formulary only since it will be excluded on NPF formulary)
- Spiriva (tiotropium) Handihaler (includes QL; applies to BCBSVT formulary only since it will be excluded on NPF formulary)
- Tiglutik (riluzole) tablets, suspension (includes QL)
- Zoryve (roflumilast) Foam
