Updated Urgent Care Clinic Definition, (1) removed the requirement of "Offers unscheduled health care services seven days per week, including holidays, for at least 10 hours per day, or, if the clinic's normal business day is shorter than 10 hours, the clinic can show evidence of availability to provide care outside of the clinic's normal business hours" and replaced with "Offers unscheduled health care services to any patient who presents for care" (2) Removed the requirement that laboratory and radiology services must be provided on site. (3) Added that Urgent Care Clinics must be registered on National Plan & Provider Enumerations System (NPPES) with a Taxonomy Code of 261QU0200X (4) removed "Is accredited by an organization approved by Blue Cross VT (including, but not limited to, the Joint Commission, the American Academy of Urgent Care Medicine, the Urgent Care Association or the National Association for Ambulatory Care)." Under Seasonal Urgent Care, removed the statement "except that is my not provide laboratory services." Updates to Provider Billing Guidelines and Documentation (1) added the requirement that claims must be billed with a rendering provider reported with the same NPI as the billing provider (2) clarified when rendering non-urgent care the claims must indicate the rendering provider.
