What is the overall deductible ?	\$3,400 individual / \$6,800 family stacked. Co-insurance and co-payments do not apply to the deductible .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . Your plan year: 01/01/2022 through 12/31/2022.
Are there services covered before you meet your deductible ?	Yes, preventive care , office visits, urgent care , emergency medical transportation , dental class I and generic prescription drugs	This plan covers some items and services even if you haven't yet met the deductible amount.
